2. Nomination papers may be obtained from the offices of the Returning Officer, Town Hall, Bexhill-on-Sea, East Sussex, TN39 3JX, during the times stated above.
3. If any election is contested the poll will take place on Thursday, 2nd May 2019.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Friday 12 April 2019. Applications can be made online:

5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Town Hall, Bexhill-on-Sea, East Sussex, TN39 3JX by 5 pm on Monday, 15th April 2019.

6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Town Hall, Bexhill-on-Sea, East Sussex, TN39 3JX by 5 pm on Wednesday, 24th April 2019.

7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Town Hall, Bexhill-on-Sea, East Sussex, TN39 3JX by 5 pm on Thursday, 2nd May 2019. The physical incapacity must have occurred after 5 pm on Wednesday, 24th April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Wednesday, 24th April 2019.
