Loading Bay in High Street

Unfortunately, a number of drivers still see this as a convenient parking spot! It's not. It is solely for the use of commercial vehicles and is there to help prevent congestion when loading or unloading. It is an offence to park in it, even for 'Just a couple of minutes' - how do you know a vehicle might not want to unload in that time? Please don't do it - the police and CSOs will issue tickets to offenders! What is the Parish Council doing about.....? In each issue of the newsletter will try to focus on one aspect of the parish council responsibilities.

Planning - perhaps not surprisingly, produces many comments to the council - it can be an emotive subject!

Why did you turn down my application? Why did you allow them to build another house next to mine? are typical of the sort of comments we get although they are not always phrased so politely! The simple answer would be that we didn't because we are not the planning authority, final decisions are made by Rother District Council. However, we are a statutory consultee and as such receive all planning applications for the parish and can comment on applications for the parish and can comment on applications anywhere in the District and Rother will always consider our views. However, they may not always agree with us or, it may be that planning laws do not allow refusal or granting of permission on the grounds that we have raised.

Why ask us then? - because they want to know the views of the parish because we are closer to the situation and may have local knowledge that they are not aware of.

They also want to know what the parish feelings are about various planning matters, for example, at an exhibition and public consultation on the proposal to build more houses in Robertsbridge, the majority of people said that they would prefer to see 'infilling' rather than 'green field' sites devel-

Do you want your village hall?

For some years now the Robertsbridge Hall has struggled to find new members for its management committee. It is not a particularly time consuming com-



mitment but, as a registered charity and to ensure that the hall continues to run smoothly, it needs to have more new mem-

bers coming along.

Last year a couple of new members were recruited but this year more are needed as both the Chairman and the Treasurer have indicated that they will be standing down at the AGM in June. Gail Amies, the Chairman, has been on the committee since it was trying to raise funds to build the hall—over 25 years and not unreasonably feels it is time for a break! Our Treasurer, David Allen, has been doing the job for nearly 14 years and is of a like mind.

We have been without a Secretary for some time but without a Chairman or Treasurer we simply cannot continue.

If no volunteers come forward to fill these posts then

oped and we have borne that in mind when considering subsequent applications - but that doesn't mean we will support approval for all such applications! We have to have regard for the area and whether it is already a relatively high density area or rural in aspect - and Rother does the same. In order to speed up decisions on planning applications, Rother DC now imposes a strict time limit for return of our comments.

Applications are considered either at full council meetings or at planning meetings which are held on alternate months; but if time does not allow this then they are considered under delegated powers by the Chairman or vice-Chairman together with the Clerk.

We always take into consideration any comments made to us; we can't always support an application but we try to be fair and consistent in our decisions and most of the time our views and Rother coincide. If they don't, we have to remember that Rother has to consider whether, if a refusal goes to appeal, will they win? Currently, appeals are taking some 50 weeks for a decision!

You can always view planning applications for the parish at the parish office during opening times or on the Rother District web site.

we shall be obliged to contact the Charity Commissioners and ask them to take over the responsibility for the hall; if they cannot find anyone to fill the posts they will have to consider how best to dispose of the property—is that what you want to happen?

The Millennium Wood

On Valentine's day 1999, scores of villagers joined forces to start the planting of Springfield Wood, 12 acres of new woodland on the northern edge of the village planted to commemorate the new Millennium. The wood was made possible by a major fund raising effort in the village and grants from various bodies. In all some 20,000 trees were eventually planted on the land. Now after 5 years of growth, the area is becoming a real wood and is in the care of the Woodland Trust - there are some superb views over the village.

The wood lies behind Rother View and Coronation Cottages and there is unrestricted access.

Safer Villages Forum

Two years ago following a public meeting we set up the Robertsbridge Safer Village Forum formed from a number of concerned residents in cooperation with Rother DC, the Police, the Youth Service and the Community College. This multi-agency approach has enabled us to tackle some of the problems that we face in the village although it often takes longer to solve these problems than it does to identify, or talk about them!

Our efforts have resulted in more police presence in the village either in the form of the Community Support Officers (CSOs), backed up by the police, or by targeted police activity and we are also working closely with the Rother Antisocial Behaviour Officer. With the help of the CSOs, we have circulated Antisocial Behaviour Order (ASBO) forms to many parts of the village and many of these have been returned. However, magistrates require a compelling case to be made for serving an order which does not comply with the usual rules of evidence; we are now close to getting ASBOs on some of the main trouble-makers – your form could make the difference! Further copies of the forms are avail-

We have through the Forum raised the issue of availability of alcohol to under age youths and we are pleased that One Stop has instituted a policy of no alcohol sales to anyone who appears to be under 21 without proof of age.

So we are trying but it's a slow process. At the public meeting 2 years ago, we asked for volunteers to come forward, in confidence, to help and over 30 people put their names forward. However, after the initial enthusiasm, this dwindled and now we have only 4 or 5 residents actively taking part and this limits what we can do. Everyone seems to be 'too busy'!. We would welcome help even if you can spare only a little time. Together we can achieve so much more and the local police inspector has said that he wants to keep the SVF going and roll out the model to other villages. If you can help, get in touch. You can contact us in person at the parish office or by 'phone or e-mail. Remember, we keep your identity confidential and we meet outside the village (not too far!) so you need not be concerned about being identified by being seen going to meetings with the police.
