Many of the bins are paid for directly by the Parish Council from the money we raise from our own residents, so it is in all our interests to ensure that the grit is used for public purposes and not taken by selfish individuals for private use. Please be community minded and, if you are able, help to spread the grit where it is intended when bad weather is forecast. And please, please keep an eye on the bin in your locality and report any misuse, as it is **you** who is being deprived by such behaviour. Grit for private use can be purchased at Culverwell’s

The Parish Council has recently approved two new grit bins; one in Langham Road and one in Rother View, at the end of the twitten path leading from Church Lane. This path is widely used by adults and children for access to the village, but is quite steeply sloped and can become treacherous in icy weather

**A Short History of Bishop's Meadow** - It seems that many local residents are unaware of how this lovely village amenity came into existence and there is still some misunderstanding about the inclusion of the small piece of the Meadow formerly occupied by the wood supply business. We thought it would be of interest to briefly outline the facts.

When the development of Mill Rise (Brightling Road, on the site of the former Stenning's wood yard) was being considered, an area of approximately 10 acres lying south of Bishop's Lane and formerly used by Stenning's to store wood, was offered to Rother District Council (RDC) for use as Public Open Space, in what is known as 'Planning Gain'. When the transfer took place the area was named 'Bishop's Meadow'.

A small area at the bottom of the land was occupied by a local resident to run his wood supply business but without a formal tenancy agreement and initially the developers wanted to remove him. However, RDC reached a compromise with the developers to allow him a lease, at a peppercorn rent, for 15 years until September 2009. Clearly, the developers were not going to give up 10 acres of land, for free, only to see it subsequently developed commercially and a legally binding contract was drawn up between the 3 parties (RDC, the developer and the tenant) to ensure that at the end of the period the land would be incorporated into the main meadow and become part of the 'Public Open Space'. The Parish Council was not involved in any of these discussions or agreements.

In 1995, the Parish Council asked Rother DC if they could have the meadow, in order to make better use of it for local people; it was not possible to transfer ownership but a lease of 99 years was granted. This included a legally binding requirement on the Parish Council to turn the area occupied by the wood yard into 'Public Open Space' on expiry of the lease and, **crucially**, not under any circumstances to renew or extend the lease. Any attempt to do so could have resulted in the developers claiming that the original transfer terms had been breached and the whole future of the meadow could be up for re-negotiation.

A public footpath runs diagonally uphill across the meadow from the entrance on Bishop's Lane to the Darvell drive but in 1996 by agreement with the Darvell community and the support of ESCC, a licensed footpath was created from the SE corner of the meadow, across Darvell land to connect up with the Glottenham drive, thus creating a safer route for walking than along Bishop's Lane and under the railway bridge. This required the construction of two footbridges across the petty sewers and these were constructed by volunteers from the village.

After the expiry of the tenant's lease in 2009, the Parish Council took control of the area formerly occupied by the woodyard, formed an earth bund across the entrance to prevent any unauthorised access and created a new access from the main meadow into the area. After many years of commercial use the land was in a poor condition and it would have cost a great deal to re-instate immediately. It was therefore scraped and levelled and is now being allowed to regenerate naturally, as indeed was the case with the main meadow.

Since the Parish Council took on the land in 1995 a great deal of work and many hours of volunteer time have gone in to developing the Meadow into the beautiful and significant environmental asset that it now is. If you haven't yet experienced the Meadow, do go and take a look – you may want to take your camera as it is rich with many species of flora and fauna. Or simply enjoy a walk around, or sit and relax in the lovely surroundings.

We have a wonderful volunteer group who carry out care and maintenance tasks in the meadow (and other pieces of amenity land); they work under the title FORGe (Friends of Robertsbridge Green spaces). ## Community Speedwatch

The Parish Council is pleased to support and publicise a new initiative in the village. A small group of residents has recently formed a Community Speedwatch Group, which is a locally driven initiative where members of the community join together with the support of the Police to monitor speeds of vehicles using speed detection devices. These activities should be viewed as educational initiatives and not enforcement.

Sergeant Paul Masterson, from Rother's Neighbourhood Policing Team, said: "Community Speed Watch is designed to get the community to work together with a little help from the local police. Volunteer operators have successfully been running this scheme in Rother for three years and membership is still growing. The scheme is ideal for those who care about their community where speeding is a priority. I would encourage you to make this positive step and make a real difference to your local area."

Details of speeding vehicles are entered onto the Community Speedwatch website by the volunteer coordinator and a letter is then sent to the driver. If the same driver is recorded speeding three times, the Police traffic department will seek to actively target and catch them.

This is a fantastic opportunity for you to do something positive for your community and give something back. All we need are people who care about their street and are willing to give a couple of hours of their time to carry out speed checks.

Freddie Pooke, local resident says: "Working closely with our county police service we in Robertsbridge are in the process of setting up our own Speedwatch group. Like many other villages in East Sussex we do have a problem with speeding and to make our roads safer and to help reduce speeding, many voluntary Speedwatch groups have been set up all over the UK. We are looking for more members to join the group so we can start to run speed monitoring sessions in and around the village. All volunteers have to attend a few hours training at Battle police station which includes health and safety basics and the use of speed monitoring devices".

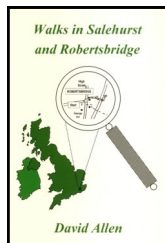

### Green Waste Collections – changes from next summer...

Residents are being urged by Rother District Council to sign up for the new garden waste collection service ahead of its launch next year. From summer 2014, a fortnightly collection of garden waste is being offered to residents for an annual charge of £25 (which RDC says works out to approximately £1 per collection).

Residents will be able to register for the service online by visiting the garden waste registration page on RDC's website ([www.rother.gov.uk](http://www.rother.gov.uk)) or calling the customer service contact centre on 0843 104 77 88 or returning the form recently distributed to all households. Those who register will receive their new brown garden waste wheelie bin shortly before the service starts and will be invoiced in spring 2014. **Those who do not register by January 6, 2014 are not guaranteed to receive a garden waste collection when the service starts.**
