WHERE WILL OUR NEW HOUSES GO?

Robertsbridge has to find spaces to absorb at least 155 new houses over the next fourteen years (up to the year 2028). This number cannot be reduced, but over the next few months, decisions will have to be made about *where* these can go, and which areas of land will be designated for development in the statutory Rother District Local Plan. Rother District Council is currently investigating potential sites and will consult the public on these next summer.



But there is another way... local people can have a greater say in making these decisions. Under the new Localism laws, we could write our own 'Neighbourhood Plan'.

All meetings start at 7:30 pm and a period of up to 15 minutes is allowed at the start of the meeting for public comment or questions, if required.

NEIGHBOURHOOD PLAN Contd...

Neighbourhood Plans enable local communities, rather than people from outside, to take the lead in producing part of the statutory development plan for the area - when passed they become part of the legal framework, and will be used in the determination of future planning applications. Without a Neighbourhood Plan the policies set by Rother DC will apply, but local people may be better placed to take account of the specific needs of our own community, and to safeguard the things we value. For a Neighbourhood Plan to be adopted, it will have to win a majority of votes from everyone on the electoral roll (in the area covered by the plan) in a referendum, so it is important that community members have been part of creating the plan, and are happy with it.



Neighbourhood Plans must conform to the District Local Plan. So a Neighbourhood Plan for Salehurst & Robertsbridge could not reduce the 155 new houses, but could influence what sort of housing it is, what it will look like, and where it should be built. It is an opportunity to protect green and other areas, and local assets such as shops, pubs, and churches. A plan could identify what additional infrastructure the community wants, and improve facilities generally.

Community Infrastructure Levy) will be introduced next year and part of the money is passed directly to the parish council to spend locally. This amount is increased when a Neighbourhood Plan is adopted.

So, clearly there are advantages but it is a serious commitment requiring careful consideration of opportunities versus time and cost implications. It is difficult to say at the moment what it would cost, except that it certainly will cost a lot of time and effort. We can benefit particularly from the experience of other local parishes that have succeeded in getting their NPs approved. Sedlescombe, the nearest parish to us who are pursuing a NP, are nearly at the end of the process, and it has cost them so far around



Local authorities receive money in various ways from developers to pay towards the cost of local infrastructure that the local authority, or local community, have identified, such as roads, schools, health centres and parks. One of these sources (the



COULD WE AVOID NEW BUILDS ON OUR GREENFIELD SITES?

Probably not. We can only hope to minimise development on greenfield sites, as the 155 houses to be built is not negotiable, and we would not have enough brownfield sites (eg. the Mill Site) and other plots for that many. The recent Croudace proposals are based on the fact that Grove Farm was designated for some development in the 2006 Local Plan.

NEIGHBOURHOOD PLANS - GIVING LOCAL PEOPLE THE POWER TO:

- have a say in where new homes should go
- set the framework to judge applications in our local context
- safeguard amenities and open spaces
- influence development in our area
- create a shared vision for the community

£15,000, spread over two years.

The cost is likely to be higher for our parish as we are bigger. But not all of the costs would have to be met by the Council Tax payers of the parish, as there are grants available. If the plan was completed over a two year period, each council-tax paying household (on band D) may have to pay an extra £5 - £10 per year.

Salehurst and Robertsbridge Parish Council (SRPC) has agreed in principle to create a NP - it is likely to go ahead if there is sufficient support, not just in theory, but individuals willing to contribute time and effort. The Town or Parish Council, where there is one, has to lead in producing

a Neighbourhood Plan. There will need to be a Steering Group to take the whole process forward, and this will include representatives other than parish councillors, from the community. There are also other roles if meetings are not for you, and

we hope that everyone will respond with their views during the various stages of community consultation (questionnaires, exhibitions, public meetings etc).



NEXT STEPS - WHERE DO YOU COME IN?

If you care about our village and want to help shape this vision for the future, and to be involved with these key tasks, we want you to take part.

Please do try to come to our first public event about a NP on Saturday 10th January 2015 in Robertsbridge Youth Centre (10 am to 12 noon), even if you are merely just curious. There will be a short talk from an experienced consultant who is giving us free help and advice, and plenty of time for questions or an informal chat over coffee. We really hope you will bring some ideas to share, as well as just hearing what's involved.
